THESE TERMS OF SERVICE ("TERMS") ARE EFFECTIVE AS OF: 1 DECEMBER 2021 "EFFECTIVEDATE". READ THESE TERMS CAREFULLY BEFORE BROWSING THIS WEBSITE. YOUR CONTINUED USE OF THE WEBSITE WHETHER AS A USER ("A USER", "YOU" OR "YOUR") INDICATES THAT YOU HAVE BOTH READ AND ACCEPT THESE TERMS. YOU CANNOT USE THIS WEBSITE IF YOU DO NOT ACCEPT THESE TERMS. Article 1. Introduction

- 1.1. These Terms will apply in respect of a User's use of the website <https://www.pikunIQ.com> ("the Website"). By using this Website, a User agrees to accept the Terms contained herein.
- 1.2. Should a User not agree to the Terms contained herein, a User must immediately desist from using this Website.
- 1.3. Minors are not allowed to use this Website.

Article 2. Intellectual Property Rights

- 2.1. The Company and/or the Company's licensors own all the intellectual property rights and materials as are contained on this Website.
- 2.2. A User is granted a limited license only for purposes of utilising this Website.

Article 3. Restrictions

- 3.1. A User may not:

- 3.1.10. Contains false or misleading information about yourself ("user") or any other parties;
 - 3.1.11. Violates any applicable law or content restrictions;
 - 3.1.12. take any action that may impose an unreasonable or disproportionately large load on this Website's infrastructure of any nature;
 - 3.1.13. use this Website in any manner would result in a User breaching any applicable legislation or licensing obligations (including with respect to privacy) or any obligations a User may owe to third parties;
 - 3.1.14. conduct any activity which compromises or breaches any third-party's patent rights, trademark, copyright or other intellectual property rights;
 - 3.1.15. introduce any virus, worm, trojan horse, malicious code or other program which may damage computers or other computer-based equipment of theCompany or affect the performance of this Website;

Article 8. Subscription Plans and Payment Processing

- 8.1. PikUniq offers three types of plans: a Flexi Plan, a Startup Plan, and a Scaleup Plan. Under the Flexi Plan, users can sign up free of charge and utilize the platform tools and features available within the Flexi Plan's offering and pay-as-you-go. The Startup and Scaleup Plans operate on a month-to-month subscription basis and require up-front payment.
- 8.2. Users subscribed to the Subscription Plans will be billed on a monthly basis. Upon subscription, users will receive tokens, which will be utilized before

any available credits are used. Tokens cannot be carried over to the next billing cycle.

- 8.3. Users have the option to cancel their subscription before the billing cycle ends. Additionally, users can upgrade to a higher plan at any time.
- 8.4. Any tokens remaining before the end of the billing cycle, if the subscription is canceled, will be available for use until the period ends. There are no carryovers on tokens.
- 8.5. All payments made through the PikUniq platform are securely processed by a third-party payment processor, Paystack. Paystack handles all payment-related information in accordance with its own privacy and security policies. PikUniq does not store any banking information on its platform.
- 8.6. PikUniq shall not be liable for any loss, damage, or harm resulting from the use of tokens, credits, or any other forms of currency or payment on the platform, including but not limited to unused tokens, expired credits, or unauthorized usage.

Article 9. Variation of Terms

- 9.1. To the extent permitted by law, the Company is permitted to revise these Terms at any time as it sees fit, without prior notice to Users, and any revisions to the Terms will take effect when posted on this Website, unless a later date is stated in the revised Terms. A User's continued use of this Website will be construed as a User's consent to the amended or updated Terms, and will be conditional upon the Terms in force at the time of use. A User's only remedy, should such User not agree to these amended Terms, is to stop the use of this Website.

Article 10. Assignment

- 10.1. The Company is allowed to assign, transfer, and subcontract its rights and/or obligations under these Terms without any notification. However, a User is not allowed to assign, transfer, or subcontract any of its rights and/or obligations under these Terms.
